### **NIKAH REQUIREMENTS:**

Please fill out the application in clear legible writing

Please read the following requirements clearly and bring the relevant documents with you on the day of Nikah.

- Requirements:
  1. Both bride and groom must be present in person on the day.
  2. Wali must be present in person
    - Wali must be the father unless he is deceased, if there are any issues with this please call the office to discuss
    - If wali is abroad- he must give power of attorney (official letter attested by solicitor) appointing someone else to act as Wali on their behalf. Power of attorney, should clearly state name of father his passport number, the fact that he is giving his consent for his daughter and the groom to marry.
  3. Valid Passport for all three (groom, bride and her wali)
  4. Proof of residential address for both bride and groom.
  5. 2 adult male Muslim witnesses and their ID (passport or driving licence)
  6. If the bride has previously been married then she should present proof of her Islamic divorce

A fee of £150/- is payable for this service. You may be asked to pay a deposit upon booking the Nikah.

Please note that the Islamic Sharia Council can only give a photocopy of the Nikah nama until the marriage is registered (i.e. a civil ceremony takes place). Once a copy of the civil registry certificate is provided we will issue the couple with the original Nikah Nama.

We require both the bride and groom to be of British or EU nationality. If one or both is not of British or EU nationality then we require a civil marriage to take place first.

If the above requirements cannot be met, the Islamic Sharia Council reserves the right to refuse to perform the Nikah.
